Subject: Moose Factory First Nation Position Re: Mushkegowuk Council

WHEREAS it is the position of Moose Factory First Nation to withdraw from the Mushkegowuk Council and its Board of Chiefs and;

WHEREAS it is the position of the Moose Factory First Nation that the Mushkegowuk Council and its Board of Chiefs are directly or indirectly interfering with Moose self-First Nation Factory government initiatives and;

WHEREAS the Mushkegowuk Council and the Board of Chiefs are directly or indirectly jeopardizing these initiatives of self-determination and;

WHEREAS the Mushkegowuk Council and Board of Chiefs are directly indirectly refusing recognize the inherent right of the Moose Factory First Nation to apply jurisdiction within its traditional land;

WHEREAS it is the position of the Moose Factory First Nation that is contrary to this principles of Mushkegowuk Council's Constitution;

THEREFORE BE IT RESOLVED that the Mushkegowuk Council on behalf of the Moose Factory First nation prepare a cost breakdown of all
