Mushkegowuk Chiefs WHEREAS created "Partners in Change" in June 1989 in order to preserve enhance the provision of quality health care services in the Mushkegowuk Region and First a unified, establish Nations controlled health care system; and

in pursuit of these WHEREAS objectives the Weeneebayko Health Ahtuskaywin was incorporated in December 1993 on behalf of the communities of New Post, Moose Factory, Fort Albany, Kashechewan, Attawapiskat, Weenusk, Moosonee and Mocreebec; and

WHEREAS the Health Ahtuskaywin is committed to support initiatives of member communities toward assuming control of the health care systems, locally regionally, through a process of transfer from the federal and provincial governments; and

WHEREAS the Health Ahtuskaywin has begun an incremental process of transfer of federal health care programs and services; and

WHEREAS the Health Ahtuskaywin is consulting with the communities for purposes of planning the future of hospital services in Mushkegowuk territory;
