### REVENUE SHARING/TAXATION BY MUSHKEGOWUK FIRST NATIONS OF CORPORATIONS TAKING NATURAL RESOURCES FROM ITS TERRITORY

WHEREAS the development of natural resources based industries and their activities of exploration is advancing at a heightened pace along the James Bay coastal region, and in particular along the Mushkegowuk territory; and

WHEREAS First Nations have historically been excluded from the consultation process, employment opportunities and revenue derived from natural resources exploration and extraction initiatives;

WHEREAS Gilles Bisson is the Member of Provincial Parliament for the Timmins/James Bay area which includes Mushkegowuk territory;

THEREFORE BE IT RESOLVED that the Mushkegowuk Chiefs in Assembly support Gilles Bisson in presenting a bill to the Provincial Legislature which would allow the Mushkegowuk communities to revenue share/tax natural resource corporations, companies and/or industries who explore and/or extract natural resources from Mushkegowuk territories.
