Resolution No. 2010-09-16

Post-Secondary Education Assistance and Support for Mushkegowuk/NAN Post-Secondary Institutions

WHEREAS we the First Nations of Mushkegowuk Council and Nishnawbe Aski Nation reaffirm and declare that we are the original peoples of our traditional lands:

AND WHEREAS we have the right and the responsibility to govern ourselves in a manner that is consistent with the responsibilities given to us by our ancestors and the Creator:

AND WHEREAS we affirm that we have never given up our inalienable inherent right to be responsible for the learning of our people;

AND WHEREAS the First Nations of Mushkegowuk Council and Nishnawbe Aski Nation are signatories to Treaty #9 or Treaty #5, which treaties committed the Crown and entitle our members to education programs and services which will enable them to achieve their personal and collective visions through lifelong learning;

THEREFORE BE IT RESOLVED THAT we affirm our right to exercise full jurisdiction and control over First Nations learning at all levels including post-secondary education and post-secondary student support programs;

AND FURTHER THAT we reject any imposition of provincial authority over First Nation education;

AND FURTHER THAT we reject any transfer of control or administration over post-secondary education or post-secondary student support program from First Nation governments or existing First Nation local education authorities to any other non-Aboriginal government department, agency or corporation;

AND FURTHER THAT we demand that Indian and Northern Affairs Canada support and cooperate in comprehensive review of the postsecondary student support program within Nishnawbe Aski Nation with the goal of strengthening, rather than weakening, the support system for NAN post-secondary students and increasing both access to, and graduation from, post-secondary programs, all under the control of Nishnawbe Aski Nation or its member such as Mushkegowuk First Nations:

AND FURTHER THAT we demand that Nishnawbe Aski Nation and Mushkegowuk Council indigenous post-secondary institutions such as Oshki-Pimache-O-Win Education & Training Institute and Omushkego Institute, be funded on a basis equivalent to mainstream colleges in Ontario.
